Dear Parent/Carer

I am writing to all our parents to offer some assistance to check the eligibility for free school meals for your child(ren).

To qualify for Free School Meals, parents can complete a simple on line application form or call the Free School Meals helpline on 01274 432772. For every student registered with the council as eligible under the entitlement criteria below, the school will receive additional funding in the school budget called Pupil Premium up to the amount of £935.00 per child which is used to help raise achievement levels. This also includes enabling access to facilities, clubs, and subsidising trips and residentials. If you do not claim for Free School Meals, then the Pupil Premium funding will not be available for your child (eg subsidising the above).

You can apply for school meals if you receive:

- Income Support
- Income Based Jobseekers Allowance
- Income Related Employment and Support Allowance
- Child Tax Credit with an annual income of less than £16,190, provided they are not receiving Working Tax Credit
- the 'Guaranteed' element of the State Pension Credit
- support under Part VI of the Immigration and Asylum Act 1999 (you will need to apply directly to the school or call the Education Service on 01274 439393)
- Working Tax Credit run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit)
- Universal Credit
